Executive Summary: The audit was carried out at Brisbane Calibrations testing facility at

Clare Avenue, Deception Bay QLD on 14 March 2012.

An entry meeting was held with the general manager Peter Pippig

and sales manager Mathew Clarke.

The previous supplier audit (Mar 2011) identified a risk regarding the reliability of Toll Aviation Wheel Bay torque meters used to verify the accuracy of torque wenches in constant use. The observation resulted in the replacement of the analogue meters with electronic meters that are permanently installed in the wheel

and brake facility.

The standard used for this audit was CASA Civil Aviation Advisory Publication CAAP 30-2(1) Feb. 2004. The guidance document requires a determination to be made if the calibration organisation is certified to a national standard.

Brisbane Calibrations is not certified to a national standard. There is a documented Quality Assurance manual reflecting current practice and work instructions. This document was referenced during the audit. CAAP 30-2 Appendix 1 section 1.2 recommends a checklist to determine a number of specified requirements. This checklist was used during this audit.

National Standards were documented in certificates issued for the scheduled calibration of the calibrator's test equipment. The calibration organisation's general manager has access to NATA accredited laboratories and performs and certifies some of these calibrations of the organisation's test equipment.

All test equipment is validated monthly in accordance with the Quality Management System and records indicated this process.

There were no findings resulting from the audit.
